Daddy my coat was too small:

Sometime in the early 1900's in North Dakota, it was an unusually warm day for March. The day dawned bright with sun and the temperature was an extremely uncommon 70 degrees. Many of the children going to school that day dressed lightly as children are apt to do, but as the day progresses the temperature began to drop and the weather began to change toward the more characteristic snow clouds and wind of the Northern Plains.

A farmer and father of three children decided to go and pick the children up at school so he hitched the horses and wagon together and began the trek to the school. The wind had increased and the snow began to come down in sheets horizontal to the ground. When he arrived he loaded the children in the wagon but before he could reach the reigns the horses spooked in the severe storm and ran away. It was hours of struggling through blinding snow and sub zero temperatures before he could see the wagon ahead. As he got closer his oldest daughter collapsed in his arms and said "Daddy, I'm sorry. I tried to cover them but my coat was too small." Reaching the wagon he found his two other children had died in the storm.

We may wonder how this applies to us as Auxiliary Volunteers but it is right on the mark. We are the larger coat that covers those exposed to danger. The active Coast Guard cannot cover it all. Without the extra coverage of the many volunteer hours of **America's Volunteer Lifesavers** we don't know where the negative public safety numbers would be but we can surmise that they would be significantly different without our input. Do not underestimate the hours you serve. You are saving lives.



St. Petersburg Beach, South Pasadena drawbridge schedule to change

ST. PETERSBURG, Fla. - The Coast Guard has approved a temporary deviation governing the operations of two drawbridges across the Gulf Intracoastal Waterway, from 7 a.m. to 7 p.m. March 2 to May 8.

The Pinellas Bayway Structure "C" drawbridge on State Road 682, in St. Petersburg Beach, Fla., and Corey Causeway drawbridge on State Road 693, in South Pasadena, Fla., will open twice per-hour compared to their current schedule of three times per-hour.

This temporary change will allow the Coast Guard and Florida Department of Transportation to gather data to determine if this schedule meets the reasonable needs of navigation while accommodating an increase in vehicle traffic throughout the area and whether it should be proposed as a permanent change.

Only vessels taller than 18 feet, which require the raising of the bridges, will be affected.

The deviation may be terminated or cancelled at any time via a Broadcast Notice to Mariners.
