

Public Education

This past month, I spent a lot of time researching tablet computers. The tablet computer is thin, lightweight, easy to travel with and carry around. Screen sizes are generally 7"-12". Many of them have excellent battery life, so you can actually get lost in an *ebook* or maybe even finish it before getting a message you need to plug in to a power source. You probably won't have to go running around the airport looking for an electrical plug during that two hour layover. We're talking 6, 8, even 12 hours of battery life.

Tablet computers use touch screens just like a smartphone and many brands of tablets use apps just like a smartphone. So, smartphone users will adapt pretty quickly to working with the touch screen. Tablets usually use an onscreen keyboard which will pop up on the screen when you need it but most operations are handled by flicking your finger across the screen or dragging across the screen like you would a computer mouse.

They connect to the Internet using a cellular connection (monthly charges apply) or WiFi from your home wireless router or at business hot spot like Starbucks or McDonald's.

The Apple iPad is one of the best known tablets on the market; prices start at about \$350



for the iPad Mini, 7"screen, up to about \$500 for its 10" screen sized big brother. The larger one is reported to be a little heavy to hold in one hand but of course the larger screen is easier to read and type on. I researched several tablets and found none of them, including the iPad, worked as well as a regular laptop computer. The more like a computer the tablet becomes, the heavier it gets, the shorter the battery life, and the more expensive they get. *Android* tablets work just like big smartphones using the same apps but have the same limitations of normal computer use a cell phone has.

The one I settled on and ultimately purchased was the *Microsoft Surface*. I bought it directly from *Microsoft* for only \$299; I got a deal.

It is small with about a 10" screen, light weight, and the battery lasts pretty much all day. It has a USB port, which lets me plug in a flash drive, camera, or full-size keyboard and mouse. This makes it much easier to use when I need to type a lot of text. It also has an optional magnetic cover that doubles as a small external keyboard

to use in those situations where you want to see the full screen while you type.

The thing that sold me the most about the *Microsoft Surface* was the fact it comes with *Microsoft Office 2013*, which is unique for tablets without full computer power. The big drawback of the *Surface* is it does not use any of the average run-of-the-mill computer programs. You won't be able to run iTunes, Photoshop, or Turbo Tax on the *Surface*. You will, however, be able to surf the Internet, read a *Kindle* book, print to a wireless compatible printer, type a *Word* document, answer an email, view the photographs downloaded from your camera or cell phone. You can play music from the Internet, or your own library of music using *Microsoft's* music player. You can watch a *Netflix* movie or other streaming media online.

The lower priced *Microsoft Surface* uses *Windows 8 RT* as an operating system, which uses apps you download only from *Microsoft*. If it turns out you like the size and features of the *Surface* but you want to run real computer programs, you will have to purchase the *Microsoft Surface Pro* for \$799. It runs the full version of *Windows 8*. You will gain computer power and flexibility but sacrifice dollars and battery life.

I purchased the *Surface* for a relative of mine who is notoriously handicapped in the area of technology. Her desktop computer with all the bells and whistles was nothing more than an expensive Solitaire game player. I was extraordinarily surprised that after a few minutes of instruction and a few hours of practice, she thought this piece of cutting edge technology was one of the easiest things to use and something she uses nearly every day.

So, if you are looking for a second computer for the house, considering a laptop computer for portability, or if you are thinking that your laptop is too bulky for travel, don't overlook the Tablet PC.

Next month, I'm hoping to tell you about *Windows 8* and the new version of *Windows 8.1*, which fixes some of the issues that scare people away from computers with *Windows 8*.

Flotilla 14-8 proudly assisted the Florida Tackle & Gun Club (FT&GC) on September 22nd with the dedication of improvements to their facility on Goodby's Creek. Their new docks and flagpole pavilion add to extensive previously completed clubhouse renovations. The FT&GC, founded in September 1944, erected their clubhouse in October 1948. The flotilla was formed at the FT&GC facility in April 1969 as the Jacksonville unit of the USCG Auxiliary. The founding members of that unit included a number of the club's members. The Florida Tackle & Gun club has remained the home and meeting

place of the flotilla since its founding.

Presiding over the Dedication Ceremony was FT&GC President Nina Duggan, introduced by Buz Palmer, longtime member of the club and a charter member of the flotilla. Uniformed officers and members of the flotilla were in attendance. Bill Sekeres, Commander, Division 14 of the USCG Auxiliary assisted the Sea Scouts, B.S.A. of Jacksonville with presenting the American flag, as well as those of the State of Florida, the U.S. Coast Guard Auxiliary, the Florida Tackle & Gun Club and POW-MIA. Raising of the flags was accompanied by a reading of "OLDE GLORY" by Nina Duggan. The National Anthem was sung by Soloist Brittany Ferrell.

The dedication on the waterfront lawn was attended by approximately 70 club members and guests, including several active and retired members of Flotilla 14-8. Guests and the Club's Board of Directors were recognized. Dock Master and Board member Denny Colbert spoke of the many advantages of the new docks, including all new lighting. The ceremony was followed by a buffet dinner inside the clubhouse.

Grant application submissions may include videos, photos or graphics or anything to potentially help increase the chances of funding. The projects with the most votes will have

one year to complete the grant project.




