#### <u>COMMUNICATIONS – KEVIN KALIL</u>



I On Saturday; 13, February, 2016. The District Level of The Coast Guard Auxiliary. (070) had a recruiting event at the Orlando, Florida Hamfest.

After the Hamfest on Saturday; 13, February, 2016. There was an informal meeting to discuss ideas about communications for the United States Coast Guard, & The Auxiliary In General.

Some ideas that were floating around were;

- A phone tree in the event of a disaster.
- Personal Radio each member has in the event of Communication failure.
- Training ideas for the use of the radio.

The Office of the Chief Director of Auxiliary has released a new set of Auxiliary Communications Program Standard Operating Procedures (SOP).

This set of SOPs provide descriptions and requirements of the Auxiliary Communications Program (ACP) along with a collection of guidelines for the conduct of specific Auxiliary communications mission activities.

The Response Directorate and Telecommunications Division have worked over the past six years to build a cohesive set of SOPs that better define the roles and responsibilities of Auxiliary communicators. A key document in this effort is the Auxiliary Communications Concept of Operations. This document provides an overarching description of the ACP and its program elements, defining the purpose, missions, components, and management of the US Coast Guard Auxiliary Communications Program.

These new SOPs cover the management and conduct of Auxiliarists operating in the following areas:

- Auxiliary Augmentation Communications (AUGCOM) Mission
- Tactics, Techniques & Procedures for AUGCOM Mission,
- Auxiliary Monitoring Station Program (AUXMON)
- Auxiliary VHF Telecommunications Program policies and procedures
- VHF Repeater Program and approval process

#### COAST GUARD "EVERYONE IS A RECRUITER" CAMPAIGN -2016



Flotilla 14-8 Member Chris Landry works 3 days a week at the North Florida Coast Guard Recruiting Office recruiting for both the Active Duty Coast Guard and Coast Guard Auxiliary

1. At the Auxiliary National Training Conference in St. Louis, MO in January, Captain Matthew Bell (Deputy Commander of the Coast Guard Personnel Service Center) and Captain Rob Smith (Commanding Officer of the Coast Guard Recruiting Command) delivered a presentation to the Auxiliary's National Board that emphasized the importance and value of Auxiliary support of the Coast Guard's recruiting program. The Coast Guard's "Everyone Is A Recruiter (EIAR)" campaign is now underway to help identify and recruit the best candidates for the best military service - the U.S. Coast Guard. The targeted age range for these candidates is 17 to 27 years of age. The Auxiliary is an integral part of this campaign, and is being turned to for help in generating Coast Guard recruitment leads and referrals. 2. In general, the best direction that Auxiliarists can lead prospective Coast Guard recruits is toward the Coast Guard recruiting web site:

www.gocoastguard.com As part of the EIAR campaign, Auxiliary flotilla, division, and regional leaders are also strongly encouraged to reach out to proximate Coast Guard recruiting offices in order to get to know each other, possibly receive limited recruiting literature and incentive items that help recruit new Coast Guardsmen, and to collaborate with regards to public outreach opportunities. Coast Guard recruiting office locations and contact information can be found in the "Find a Recruiter" section of the Coast Guard recruiting web site: www.gocoastguard.com

- 3. Limited supplies of recruiting materials provided by the Coast Guard Recruiting Command have begun arriving at the Auxiliary National Supply Center (ANSC).
- a. These materials will be carried on the ANSC inventory available for order by Flotilla Commanders (FC) and Flotilla Staff Officers for Materials (FSO-MA). Materials should not be ordered unless absolutely sure that they will be used in full and timely manner. Four types of materials will be available:
- (1) Coast Guard recruiting business cards (these are the most effective recruiting tool due to their simplicity and direct message).
  - (2) Coast Guard Roles and Missions brochures.
  - (3) FAO brochures.
  - (4) 9/11 GI Bill brochures.
- b. The Coast Guard Recruiting Command has also advised that there are still many outdated recruiting materials in circulation, specifically items with a "1-800" or "1-877" telephone number on it (e.g., pencils, tablecloths, etc). The Coast Guard Recruiting Command no longer uses any such telephone numbers...just the www.gocoastguard.com web site. Any legacy recruiting materials with phone numbers on them must not be distributed but rather disposed of.
- 4. There is an "Everyone Is A Recruiter" section on the Auxiliary's national Human Resources Directorate web site:



And for each of those enrollments, the Flotilla will receive a revenue share of \$5.00.

This \$5.00 per enrollment can be earned just by using personal contacts with boaters to inform them of the course, all without the time, space and outlay of flotilla funds required to put on a class.

#### **Mandarin News**

Safe Intentions By Contributing Writer Ralph Little, Flotilla 14-8

Subjects to write about come to me in many ways. Recently a boater's question during a vessel examination of his personal watercraft at the Mandarin Park ramp turned into a good topic. His inquiry was about whether PWCs can operate at night with the appropriate navigation lights – which he had. In answering that, I must also observe that portraying a regulation

accurately sometimes goes awry due to a poor choice of words, perhaps coupled with an attempt at being succinct or alternatively offering too much explanation. Examiners repeatedly go over some issues that could have been stated better, whether in Federal or State sources. Other issues falling in this category include the display of registration numbers and distress signal requirements.

The Florida Fish & Wildlife Commission Boater's Guide states, "PWCs may not be operated during the hours between one half-hour after sunset to one half-hour before sunrise. Due to navigation light requirements after sunset and before sunrise, PWCs without navigation lights may operate only between sunrise and sunset." I would have stopped after the first sentence. The second sentence confuses by stating the general rule for navigation lights and when PWCs without lights are allowed to operate. It omits the key clarification that only PWCs with navigation lights are permitted to operate in that half hour after sunset and before sunrise.

The FWC's regulation online at myfwc.com varies from their Boater's Guide statement, and is better by stating PWCs can't operate after dark "even if navigation lights are used", but it and their brochure, Florida's Recreational Boating Requirements, also confuse with seemingly contradictory general

information about navigation lights.

The more succinct answer is "no", PWCs are not allowed to operate in full darkness in Florida or 34 other States, even if they have navigation Federal regulations appear to leave the issue to the States. Many national parks prohibit PWC use and others have a regulation that their prohibits night operation, offering the reason that PWCs are considered too dangerous to operate at night.
